## Circuit Clerk

Clerk for Bond County Court. Collects fines; responsible for Jurys; files, records and stores all court forms (divorce, small claims, etc) and issues passports.

## General Administration

Covers items that affect the whole county government. The IT Director coordinates the county's technical operations ensuring all systems safely support the county's goals.

## County Clerk

Issues Marriage License, maintains vital records, collects back taxes, registration of assumed name, records and maintains all land records, responsible for extension of taxes, responsible for all county payables, maintains voter rolls and runs elections.

## Treasurer

Responsible for the receipt, investment and disbursement of revenue and public money for the county. Also serves as the Bond County FOIA officer

## States Attorney

Prosecutes all violations in Bond County. Also serves as the attorney for Bond County.

## Sheriff

Serve and Protect the citizens of Bond County.

## Animal Control

Responsible for rabies control, picking up stray animals, running the pounds and striving to return animals to owners whenever possible.

## Public Defender

Attorney appointed to represent people who otherwise cannot reasonably afford to hire an attorney.

## Health Department

Serves the health needs of Bond County through home health, hospice, behavioral health, dental health, family planning, vaccinations and much more.

## County Board

Governing body of the county. Passes all resolutions and annual budget.

## Zoning

Issues permits for building. Oversees the zoning and building code ordinances.

## 911

Oversees 911 and emergency preparedness in the county

## Probation

Administers probation services in Bond County.

## Coroner

Responsible for death investigations and declaration in Bond County.

## Supervisor of Assessments

Assesses all property in Bond County in a fair and uniform manner as mandated by the Illinois Property Tax Code.

## Special Service District

Purchases and maintains ambulance equipment.
